Atmospheric Pilot Regulators

"Zero gas" pilot systems require an atmospheric regulator to supply gas at zero gauge pressure to the pilot mixer. The 7350- - A is suitable for single pilot installations, or for several pilot tips manifolded off a common mixer, provided its capacity is not exceeded. For more tips use a 7218 Regulator, -1 or larger.

If inlet gas pressure exceeds 1 psi to the 7350- -A or 2 psi to the 7218, use a pressure-reducing regulator upstream. 7344 Regulators reduce up to 25 psi gas to 4-12"wc--see page 2.

For capacities or inlet pressures beyond the range of 7344 Regulators, see Bulletins 7337 and 7349.

7350- -A and 7350

Maximum recommended capacity is 303 scfh for the ½" regulators and 274 scfh for the ¾" regulators. These capacities occur at 2.5"wc pressure drop.
